From the President

2007 was truly an amazing year for Mothers' Club. We set a lofty goal of raising \$6.5 million to purchase and construct our new Family Learning Center at 980 North Fair Oaks Avenue in Pasadena, in the heart of the Northwest community. As of June 30, 2007 we had raised over \$5 million and were on track to meet our goal by November 1, 2007. Construction was well underway and we were planning to move into our new home in October 2007. All of this was made possible by the generosity of our donors, the hard work of our Board, and the dedication of our staff.

Looking back on how we arrived at this point, it has been a remarkable journey. We adopted our Strategic plan in May 2005 after two years of outreach and dialogue with our community. With the plan's adoption, we committed to conducting "a capital campaign to secure a permanent home for Mothers' Club" that would meet existing program needs and allow for expansion. By November 2005 we were in escrow for the property on North Fair Oaks. Now, just



two years later we are in our new home and moving forward!

We are making plans to grow our services. No longer constrained by inadequate facilities and limited hours, Mothers' Club will be able to serve our families in an environment that is state-of the art. The Board made a decision to construct a facilitv that would achieve a Gold level L.E.E.D. designation (Leadership in Energy and Environmental Design). Signs of this achievement can be seen throughout the site, including the photovoltaic cells that generate more than 30% of the building's power. We also made a commitment to become a licensed pre-school facility. Our staff is already at work filing the necessary documentation with the State of California to achieve this milestone.

Our Strategic Plan included a goal for increasing Mothers' Club's visibility in the community. Our new location, new logo, and new descriptor name, Mothers' Club Family Learning Center, are all contributing to this effort. We are also pleased that the number of people who contribute at the Guardian level continues to grow. Our Guardians provide stable operating revenue and are a critical part of the Mothers' Club family.

What a year for Mothers' Club! After serving Pasadena for over 45 years, we have now secured our place in Pasadena for AT LEAST another four decades. Thanks to all of our friends, donors, and volunteers who have made this a transformational year for Mothers' Club.

Our Mission

Mothers' Club prepares families living in isolation and poverty to succeed in school and in life. We promote strong parent-child relationships and encourage friendship and mutual support among mothers through our education programs and social services, thereby creating a stronger community for all families.

About Mothers' Club

Founded in 1961, Mothers' Club is built on two guiding principles: in order for significant, long-term change to occur within a family, you must reach both parent and child and educate them together; and the most critical time to reach a family is when children are proven to be most vulnerable and impressionable, between birth and five years-old.

Mothers' Club reaches families in Northwest Pasadena, one of the most densely populated, impoverished areas of Los Angeles County where 40% of families with children under five live below the federal poverty level, and 49% of adults 25 years and older do not have high school diplomas. Of the families served last year:

- √ 91% of children were living in poverty;
- √ 62% of parents did not have high school diplomas, with 47% having less than a 9th grade education;
- ✓ and 71% spoke a language other than English in the home.

Early Childhood Education

It is our vision that all children in our community will be nurtured and educated during their first five years, they will develop healthy bonds with their parents and teachers, and enter kindergarten ready and able to learn.

Our research-based curriculum promotes healthy social/ emotional, physical, cognitive and language development, as well as self-worth and confidence. We have five developmentally appropriate classrooms for infants, toddlers, two-year-olds, preschoolers and pre-kindergarten children.



Parenting & Adult Education

It is our vision that every mother in our community will be prepared for her role as her child's first and most influential teacher. She will know that she is never alone as a parent, and that she is a life-long learner. The following are some of the classes and activities that make up our program for parents:

2007 Highlights & Accomplishments

Opening our New Home

After 46 years of being a tenant and having to set up and break down our classrooms each day, we now have a wonderful learning center designed specifically for our two-generation learning model. Our center at 980 N. Fair Oaks Avenue opened in October 2007 and families were overwhelmed by their new home. One mother said to Executive Director Sue Kujawa, "Oh, we don't deserve this." Ms. Kujawa replied, "Yes, you do!" Everyone deserves inspiring, thoughtful spaces in which to learn and grow.



An Exemplary Family Literacy Program

In 2007, Mothers' Club was one of only three programs in Los Angeles County to participate in an evaluation process designed by the Family Literacy Support Network to be validated as an Exemplary Family Literacy Program. The rigorous eight month long process involved amassing a portfolio of evidence documenting the array of best practices used by the agency throughout its family literacy program.

Barbara VanHorn of the Goodling Institute at Penn State and Chris Dwyer from RMC Research and Evaluation Corporation reviewed the best practices to verify that they indeed lead to exemplary outcomes for young children and families. One of the objectives of the validation process is for programs to demonstrate how program activities influence child school readiness, increase family involvement, and family goal achievement. Mothers' Club received validation in October 2007.

Best Practices Support Positive Learning Outcomes for Parents and Children

In its 2007 program year, Mothers' Club **served 78 parents** with **85 children**. Year-end assessments revealed that children are on track developmentally and ready for school, and parents are gaining the skills and confidence they will need to help their families and themselves achieve success in the future.

2007 Outcomes for Children

- √ 100% of preschool children entering kindergarten demonstrated growth 98% of the time in the preliteracy and other skills known to support a successful transition into kindergarten
- √ 100% of children from birth through four-yearsold demonstrated growth in all development areas: cognitive, social/emotional, physical and language skills

2007 Outcomes for Parents

- √ 74% of adults studying English as a Second Language achieved a 3-5 point gain on their Comprehensive Adult Student Assessment System test score, demonstrating a significant increase in their English language writing skills.
- 96% of parents reported reading to their children3 or more times per week
- √ 96% of parents reported having at least 26 children's books in their home

Attendance & Retention - The Keys to Success

- More than 95% of families remained at Mothers' Club for the entire year or met their personal goals and completed the program.
- Families attended Mothers' Club at an 87% attendance rate.
- High attendance and retention rates are critical to any successful program, and they exemplify the commitment families have made to breaking the cycle of poverty and illiteracy within their families.
